We invite you to apply for the Winter 2008 advocate course known as the **Parent Leadership Support Project (PLSP)**. This program was founded by the Georgia Advocacy Office, the protection and advocacy system that protects the rights of persons with disabilities in the state of Georgia. As part of its commitment to helping all children in Georgia to have the benefit of knowledgeable and effective advocates, the Georgia Advocacy Office is proud to invite you to apply for the Parent Leadership Support Project.

This is the eighth Parent Leadership Support Project to be offered in Georgia. Since its inception in 2003, the Parent Leadership Support Project has seen 180 dedicated advocates graduate from the program. The Georgia Advocacy Office is now proud to invite interested individuals to apply for this 11-week training experience, especially citizens who are currently involved in advocacy issues or have the competency and compassion to be involved in advocating for others.

You are receiving this letter because you have inquired about this project and/or you were referred to the Georgia Advocacy Office by one of your peers. Information outlining the project and expectations follows. An application form is included.

## PLSP OBJECTIVES

◆ To assist and enable concerned citizens to master information and negotiate systems in order to help secure the educational opportunities that are a civil right and legal mandate for students with disabilities

- ◆ To provide trainees with the best information on the complex issues surrounding Georgia's educational system to raise competency levels of people advocating on behalf of students with disabilities
- ◆ To present professional speakers who educate trainees and give the project a hands-on, in-depth view
- ◆ To develop long-standing relationships between concerned citizens and parents
- ♦ To understand how valued social roles lead to a full life

# WHO SHOULD APPLY

- People with disabilities or people with family members who have disabilities
- ◆ Citizens who receive no financial support from a school district or State Board of Education
- ◆ Persons of all ethnic and cultural backgrounds
- ♦ People with the passion and time to lend to advocating for others

#### WHAT YOU CAN EXPECT

The participants will attend 11 sessions, most of which will be held on Wednesdays from 9:30 a.m. to 1:00 p.m. The first and last sessions will be held on Saturdays. The first session will take place on Saturday, January 12, 2008, from 10:00 a.m. to 3:30 p.m. The last session will be held on Saturday, March 22, 2008, from 10:00 a.m. to 3:30 p.m. All sessions will be held in Atlanta, Georgia.

#### WHAT WE EXPECT

- ◆ Each participant is expected to attend all sessions. If a participant is absent on two (2) occasions from the course, then the participant will be excused from this course and will be able to attend the next and/or future courses.
  - Attendance is the single most important expectation of a participant.
- ♦ Each participant will participate in the Yahoo Listserv dedicated to PLSP participants for at least one (1) calendar year starting from the first day of training. All previous PLSP graduates are also subscribed to this Listserv and the response has been overwhelmingly positive.
- ◆ Each participant will complete all homework assignments, designed to prepare participants for each session.
- ♦ Upon completion of training, each participant will attend a minimum of six Individual Education Plan meetings for a student other than their own and/or impact the educational system in a significant manner.
